

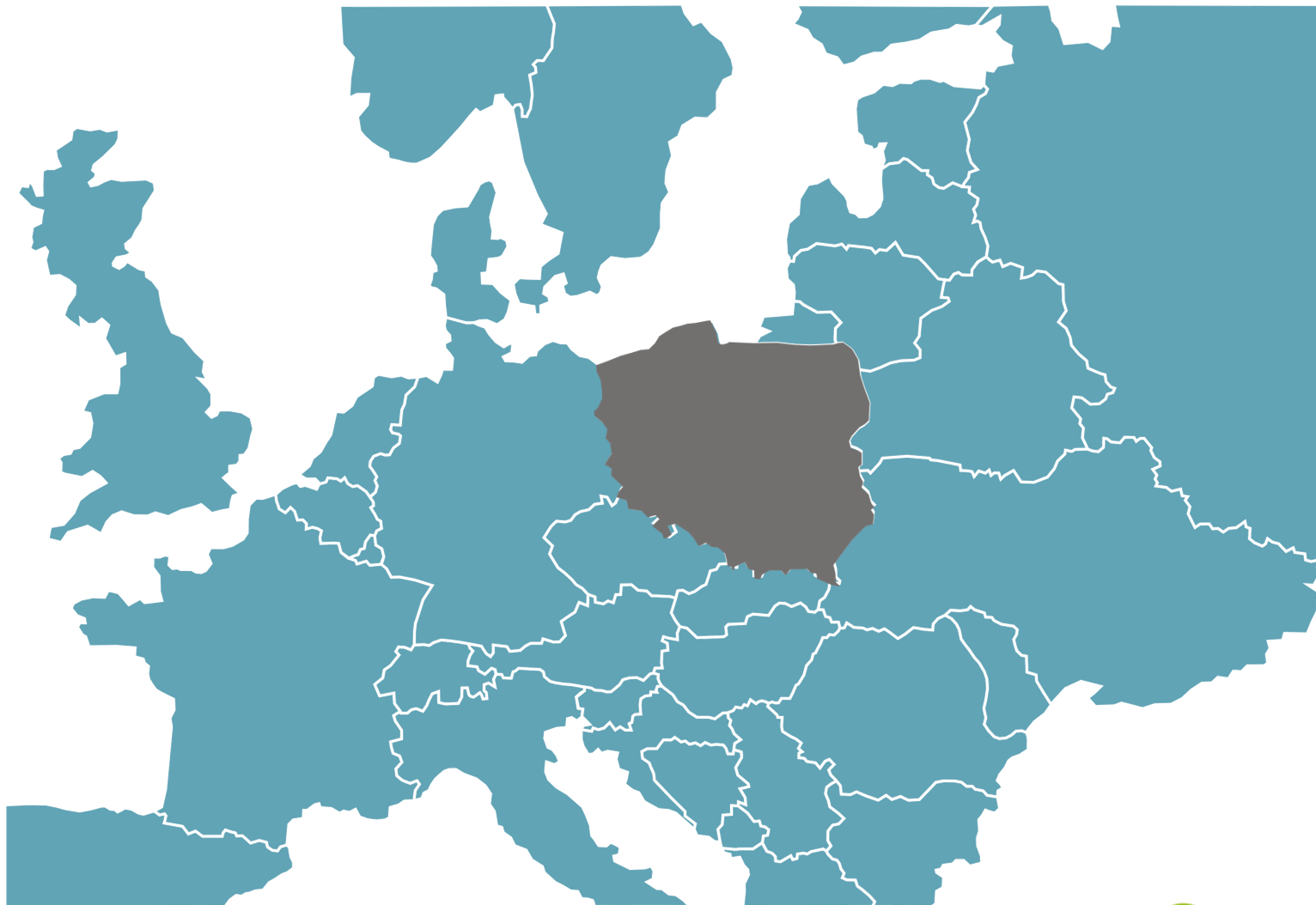

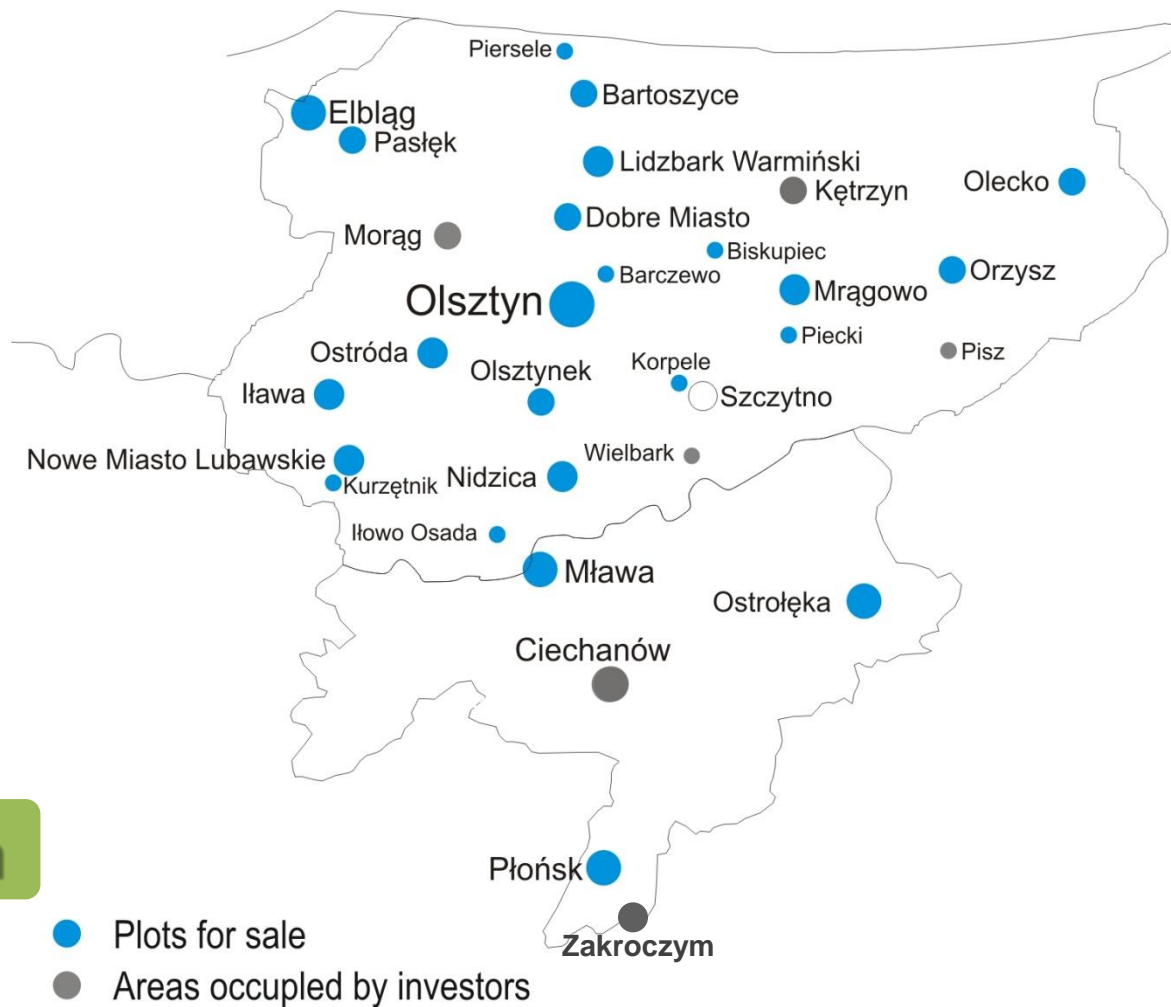

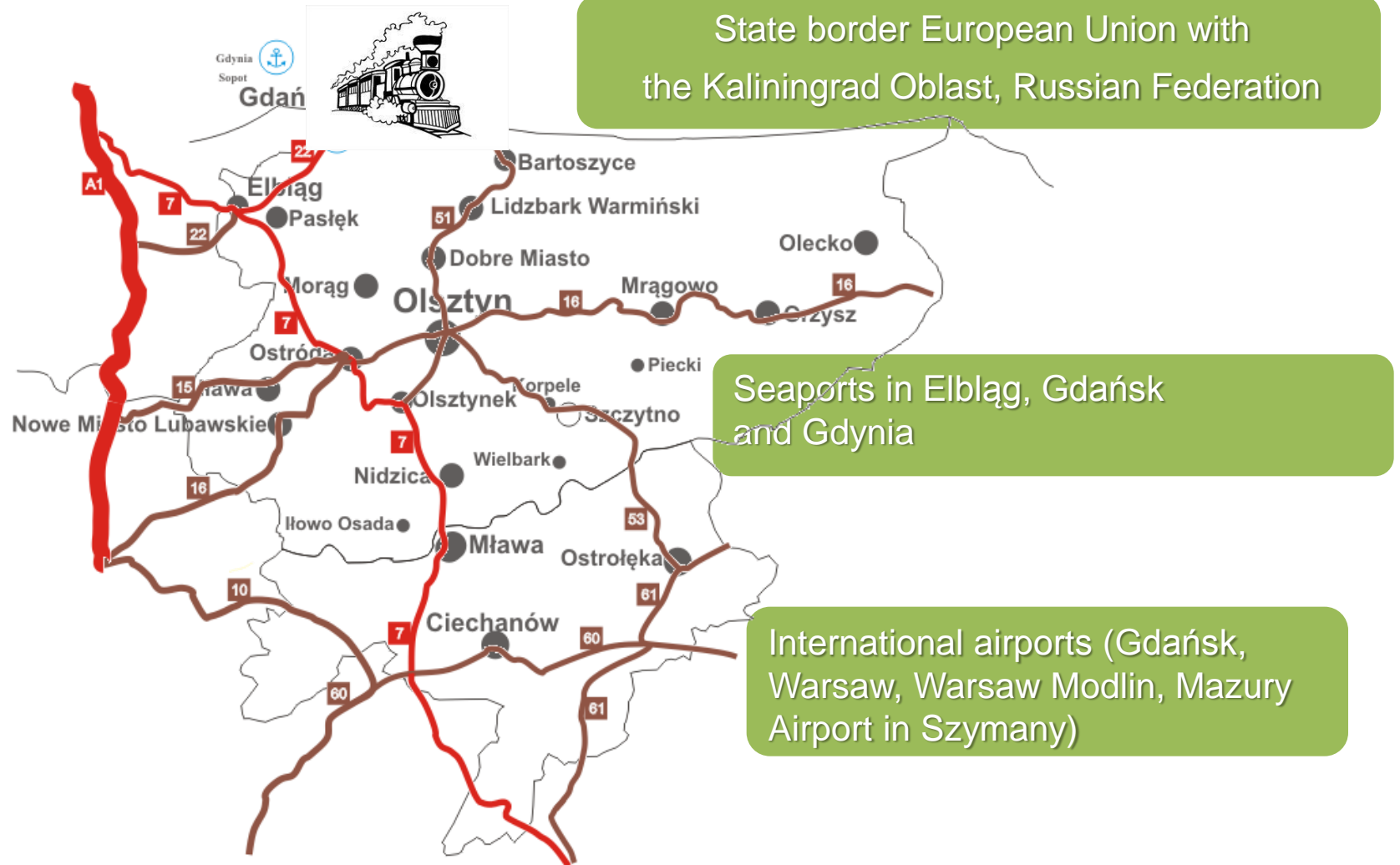

food processing, furniture, agriculture, renewable energy.

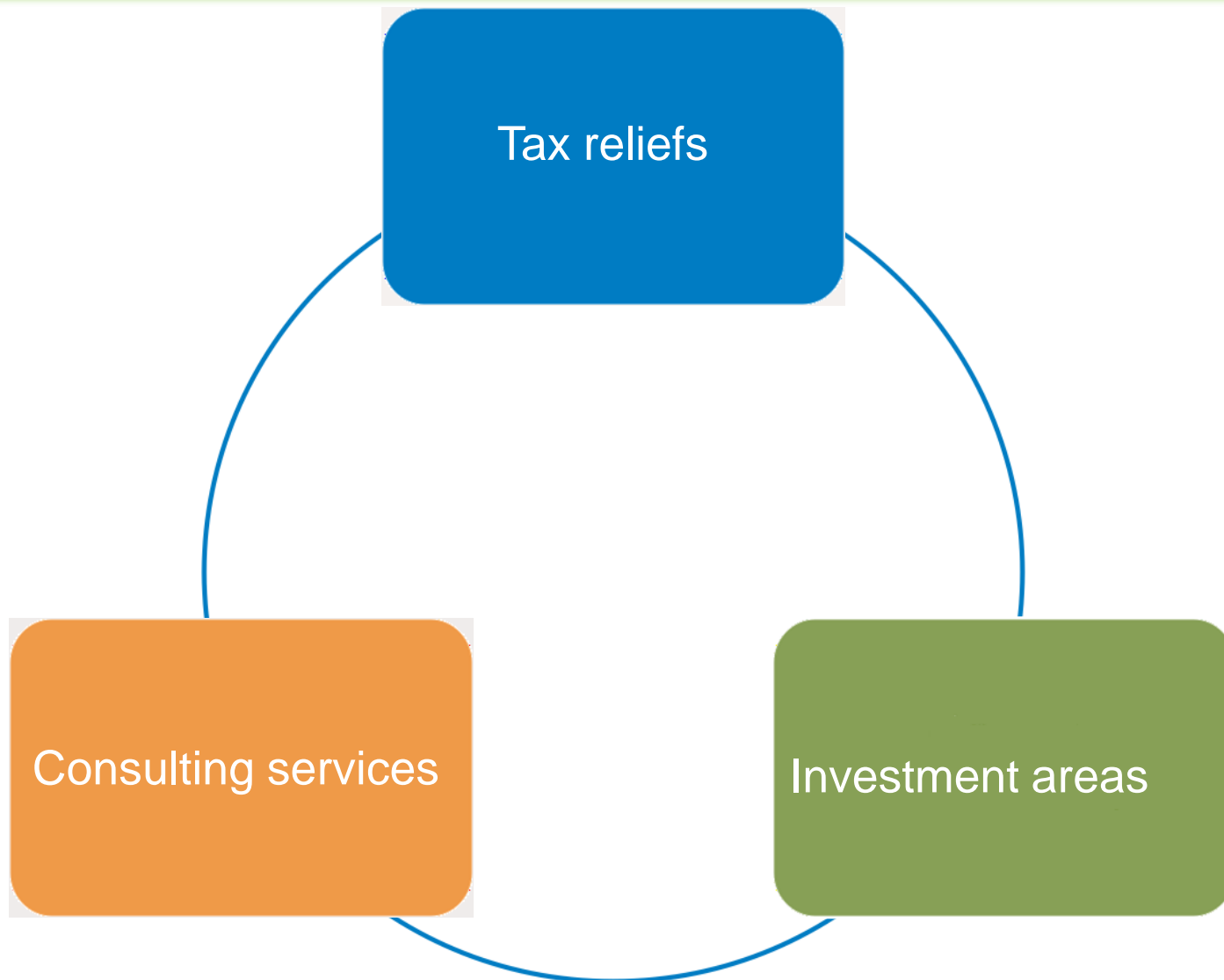
Investment advantages in Mazovia Region:

EXEMPTIONS AND PREFERENCES

- THE HIGHEST LEVEL OF THE STATE AID IN THE FORM OF INCOME TAX EXEMPTION
- ENTREPRENEURS INTERESTED IN COMMENCEMENT OF THEIR ACTIVITY IN WMSEZ CAN USE STATE AID OF UP TO **70%** OF ELIGIBLE COSTS OF INVESTMENT OR TWO-YEAR LABOUR COSTS.

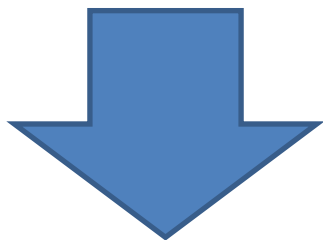

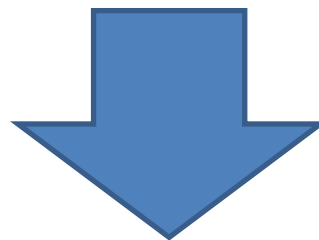

EXEMPTIONS AND PREFERENCES

ENTREPRENEURS WHO HOLD A PERMISSION TO RUN BUSINESS ACTIVITY IN THE AREA OF THE WMSEZ ARE ENTITLED TO BENEFIT FROM PUBLIC AID IN THE FORM OF INCOME TAX EXEMPTIONS

EXEMPTIONS AND PREFERENCES

For the Warmia and Mazury Region, the regulations establish the maximum amount of aid at the level of 50% (35% in part of Mazovia Region) of eligible costs of a new investment, or 50% (35 % in part of Mazovia Region) of two-year labour costs of newly hired employees.

In the case of medium enterprises, the regulations increase the maximum amount of aid by 10%, and in the case of small enterprises – by 20%*

*excluding businesses in the transport sector

Definition of small and medium enterprises.

A medium enterprise is an enterprise that hires less than 250 employees and whose annual turnover does not exceed EUR 50,000,000 and/or an annual balance-sheet total does not exceed EUR 43,000,000.

A small enterprise is an enterprise that hires less than 50 employees and whose annual turnover and/or total balance do not exceed EUR 10,000,000.

CONDITIONS

- investment of minimum 100 000 EUR,
- continuance of the investment in the region for at least 5 years after completion of the whole investment (3 years for SME),
- maintenance of employment level for at least 5 years (3 years for SME),
- own capital is at least 25% of total investment costs,
- tax exemptions eligible only for economic activity realized on the area of special economic zone.

EXEMPTIONS

Examples of businesses which cannot be used to obtain a tax exemption:

- Agricultural production
- Licensed business activity – power industry law
- Production of tobacco products and alcoholic beverages
- Wholesale and retail trade

EXEMPTIONS FROM REAL PROPERTY TAX



The municipal council may establish exemption from real estate tax for entrepreneurs

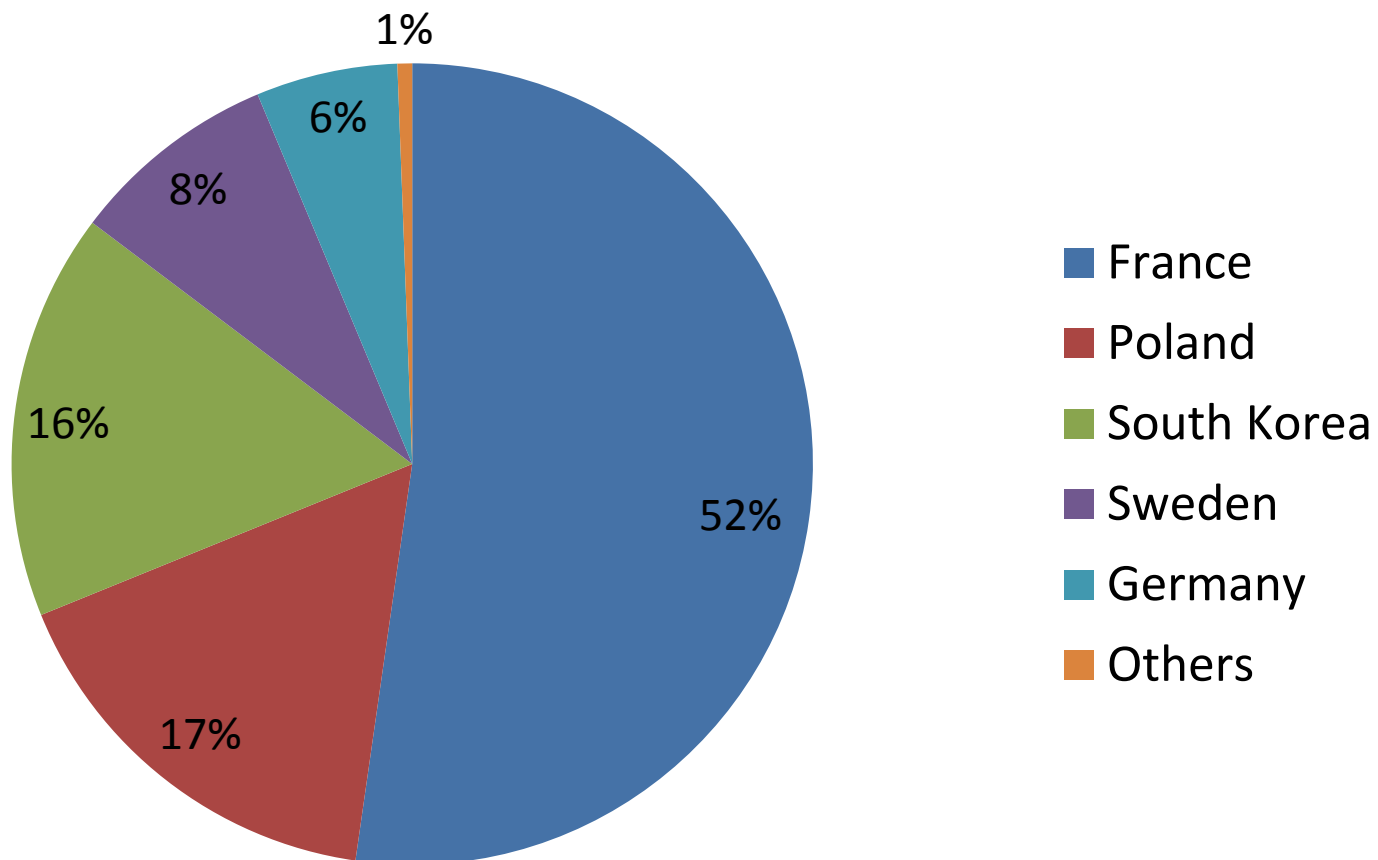
